Minutes of the meeting on review of the progress on implementation of "Special programme for promotion of millets in tribal areas of Odisha" & "Special programme for promotion of integrated farming in tribal areas" held on 26.07.2017 under the chairmanship of Development Commissioner cum Additional Chief Secretary

A meeting was held under the chairmanship of Development Commissioner-cum-Additional Chief Secretary on 26.07.2017 at 3.30 PM in the Conference Hall of Planning & Convergence Department to review the progress on implementation of "Special programme for promotion of millets in tribal areas" & "Special programme for promotion of integrated farming in tribal areas of Odisha". The members present in the meeting are as follows:-

1. Principal Secretary, Department of Agriculture & Farmers Empowerment
2. Director, Scheduled Caste, Scheduled tribes and minorities welfare Department
3. Director, Directorate of Agriculture & Food Production, Odisha
4. Director, Nabakrushna Choudhury Centre for Development Studies (NCDS), Bhubaneswar
5. Deputy Secretary, Women and Child Development Department
6. Programme Secretariat, WASSAN


At the outset, the progress of the programme was presented by the Director of Agriculture & Food Production, Odisha. He stated that the programme on millets has received very good response from the farmers. The Director, NCDS explained the issues that have emerged during the course of implementation of "Special programme for promotion of millets in tribal areas" & "Special programme for promotion of integrated farming in tribal areas of Odisha". Discussion was made regarding necessary amendments required in the guidelines/EFC of the "Special programme for promotion of millets in tribal areas" & "Special programme for promotion of integrated farming in tribal areas of Odisha". Discussion was also made regarding marketing of millets & other organic products as well as inclusion of millets in State Nutrition Programmes under ICDS, MDM and ST & SC Welfare hostels.

Following decisions were taken in the meeting with regard to successful implementation of both the programmes:-

1. It was decided to make necessary amendments in the existing guidelines /EFC of the "Special programme for promotion of millets in tribal areas" as mentioned herewith:-
 - a) Amendments without the budgetary implication (enclosed at Annexure-1), which will be applicable with retrospective effect from date of signing of MoU.
 - b) Amendments with the budgetary implication (enclosed at Annexure-2)

2. Necessary amendments in the existing guidelines of the "Special programme for promotion of integrated farming in tribal areas of Odisha" without the budgetary implication are enclosed at Annexure 3.
 3. It was decided to expand the "Special programme for promotion of millets in tribal areas" to 25 new blocks in the next financial year to be funded under RKVY as per revised norms as approved herewith. Programme Secretariat shall finalise the 25 blocks in consultation with NFSM cell and prepare project proposal before 5th September, 2017. Advertisement for expression of interest should be given by the programme secretariat before 15th September, 2017. Programme Secretariat shall complete pre-project implementation of activities such as selection of NGO for FAs and CBOs before December 2017.
 4. A working group on mainstreaming of millets programme will be formed with the officials of the following Departments i.e. Planning & Convergence, Agriculture & Farmers' Empowerment, ST & SC Development, minorities & Backward classes Welfare, School and Mass Education, Women & Child Development and Mission Shakti, Food Supplies & Consumer Welfare, Micro, Small & Medium Enterprise along with NCDS & Programme Secretariat (WASSAN) to finalise the strategy for inclusion of millets in PDS, ICDS, MDM and ST & SC Welfare Hostels. Working group will finalise the timeline for the development of the road map and process manual for inclusion of millets in the PDS, ICDS and MDM.
 5. Meeting is to be convened with MSME officials, APICOL, ORMAS, wholesalers and retailers, biscuit manufacturers, millet product makers, reputed bakeries, hospitality management schools, Start Ups and other relevant stakeholders for developing strategy on marketing of millets.
 6. Keeping in view the need of the professional agencies to manage the marketing of organic products, Director, NCDS cited one such agency namely Centre for Sustainable Agriculture (CSA), Secunderabad that has large scale experience in branding of the organic products and running stores in Telangana and Andhra Pradesh. Their expertise will be helpful in this regard. It was decided that two stores currently managed by Udyan Fresh shall be allocated to CSA to initiate branding and marketing of organic products of PKVY clusters along with millets products under Millet Mission Odisha.

Annexure 1 : Amendments approved without changes in the Budget Allocation for Special Programme for Promotion of Millets in Tribal Areas		
Sl.No.	Provision in the existing guideline/ EFC	Approved Amendment
1	Programme Facilitation funds for the Facilitation Agencies, Programme Secretariat and Research Secretariat were provided at Component 8, 9 and 10 in the Annexure 1 (Detailed Break up of Block wise Budget) of the EFC on "Special Programme for Promotion of Millets in Tribal Areas". Detailed break up are provided further at Annexure-2, Annexure-3 and Annexure-4 of the aforementioned EFC.	During the implementation of the programme it was found that the detailed breakup of the budget is no longer relevant as the target area has been increased. Hence based on the recommendation of the NCDS communicated to the Department of Agriculture & Farmers' Empowerment, amendment has been made to provide the programme facilitation costs to the FA and State Secretariat as lumpsum grant on annual basis without additional allocation. Previous break up of Programme facilitation budgets in the Annexure-2, Annexure-3 and Annexure-4 of the EFC will be no longer valid. FA and State Secretariat are to use the budget flexibly as per the needs of the program for field visits, employing more staff, employing temporary experts for any activity, NGO overhead expenses, audit expenses, etc. for the programme.
2	Costs for centralised training and meetings were provided at Component 11 and 12 in the Annexure 1(Detailed Break up of Block wise Budget) of the EFC on "Special Programme for Promotion of Millets in Tribal Areas". Budget provided per person per day is Rs 400 as per block level NMAET norms.	As many trainings & meetings were conducted at state level and regional level to meet the requirement, amendment is made in the existing cost norms at Component 11 and 12 in the Annexure 1 of the EFC following ATMA GUIDELINES, 2014 under NMAET for conducting Capacity building and meeting events by the State Secretariat at the State Level/Inter District without additional allocation of budget. Travel budget for the participants will be applicable as per originals without exceeding the overall allocation.
3	Detailed Budget break up for the Block level Capacity building programme i.e. Rs 400 per person per day was not proposed in the EFC of Special Programme for Promotion of Millets in Tribal Areas.	The budget break up proposed by the NCDS (State Secretariat) for the Block level Capacity building programme i.e. Rs 400 per person per day is to be finalised at the level of D.A. & F.P.O by forming a committee.
4	Detailed budget break up for the farmer incentive was not proposed in the in the EFC of Special Programme for Promotion of Millets in Tribal Areas.	The budget break up proposed by the NCDS (State Secretariat) for the Farmer incentive i.e. Rs 5000 per farmer under System of Millet Intensification (SMI) and Rs 2500 per farmer for line sowing line transplanting is to be finalised at the level of D.A. & F.P.O by forming a committee.
5	There is no provision of funds for monitoring of the programme by ATMA.	Project Director, ATMA (Agriculture Technology Management Agency) shall utilise funds available under Administrative / Capital expenses at District and Block level of ATMA for monitoring of the programme.
6	Program Secretariat will develop Web-Based MIS system with login facility with a process of updating data on real-time basis and regular monitoring of the programme (mentioned in the guideline at point 4.0)	As IT platform is still under development, Project Director, ATMA shall ensure farmer incentive credited by manual eye estimation by the block level or field functionaries. 15	There was a provision of four seed centres for one block under component 3.1.2 of Annexure 1 in the EFC of Special Programme for Promotion of Millets in Tribal Areas.	Depending on the block, more or less number of seed centres is required. Hence flexibility in number of seed centres is needed without additional allocation. If required, additional budget shall be sourced through inter-componental transfer with approval of the Collector & District Magistrate cum Chairman Governing Body, ATMA.
16	There was a provision for financial support to Entrepreneurs on loan basis for establishing pulverising / grinding enterprises for local consumptions at clusters of panchayat level (Total of 10 Nos per Block)" under component 2.1 of Annexure 1 in the EFC of Special Programme for Promotion of Millets in Tribal Areas,"	Financial Support to Entrepreneurs for establishing pulverising/grinding enterprises for local consumptions at clusters of panchayat level (Total of 10 Nos per Block)" shall be provided as a grant.
17	There was a provision for financial support to Block level enterprises on processing & value addition under component 2.2 of Annexure 1 in the EFC of Special Programme for Promotion of Millets in Tribal Areas.	Entrepreneurs on Ragi, small millets, coarse cereals processing projects can also be promoted through the Commercial Agri- Enterprise (CAE) scheme of State agriculture Policy, 2013.
18	There was a provision for documentation of Small video films - community level (recipes & production practices) for local community video communication @12 - 15 mins under the Component 1.4 of Annexure 1 in the EFC of Special Programme for Promotion of Millets in Tribal Areas,	As the video making budget available under the Component 1.4 is much lower than prevailing local market rates, films shall be made at district level instead of block level by centralised contract for video making at the ATMA level @5 - 7 minutes through tender.

State Secretariat started working on the project since April and FAs started working since June 2017. Additional budget provision shall be made for 1 month for FAs and 3 months for State secretariat. These additional funds can be met through inter-componental transfer of unspent funds from the programme with approval of the D.A. & F.P.(O).
2	Administration budget provided to NGOs mentioned at Annexure-2 of the EFC is Rs 22.11 Lakhs for 5 years per block.
